Personal data that we process

We use UwBoeking.com, which processes your personal data for us by using our services and/or by providing this information to us.

Below is an overview of the personal data we process:

- First and last name
- Address data
- phone number
- E-mail address

Special and / or sensitive personal data that we process

Our website and/or service does not intend to collect data about website visitors who are younger than 16 years of age. Unless they have permission from parents or guardians. However, we can not check if a visitor is older than 16. We encourage parents also to be involved in the online activities of their children, to prevent that data about children is collected without parental consent. For what purpose and on what basis we process personal data

De Rijnstrangen VOF processes your personal data for the following purposes:

- To be able to make the reservation.
- Handling your payment
- Rijnstrangen VOF also processes personal data if we are legally obliged to do so, such as information that we need for our tax return.

Automated decision-making

Rijnstrangen VOF does not make decisions based on automated processing on matters that can have (significant) consequences for persons. These are decisions taken by computer programs or systems, without a person (for example an employee of De Rijnstrangen VOF) sitting between them. Rijnstrangen VOF uses the following computer programs or systems:

- www.uwboeking.com. We use this system to manage reservations. We use your data in this system to generate invoices, and to generate general statistics.

How long we store personal data

Rijnstrangen VOF does not store your personal data for longer than is strictly necessary to realize the purposes for which your data is collected. We use the following retention periods for the following (categories) of personal data:

- Personalia > 7 years> Because of compliance with the Tax Act.
- Address > 7 years> Because of compliance with the Tax Act.
- phone number > 7 years> Because of compliance with the Tax Act.
- E-mail > 7 years> Because of compliance with the Tax Act.

Sharing personal data with third parties

Rijnstrangen VOF shares your personal data with various third parties if this is necessary for the execution of the agreement and to comply with any legal obligation. With companies that process data on our behalf, we conclude a processor agreement to ensure the same level of security and confidentiality of your data. Rijnstrangen VOF remains responsible for these processing operations. The addition Rijnstrangen VOF provided personal information to third parties. We only do this with your express permission.

View, modify or delete data

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent to the data processing or to object to the processing of your personal data by De Rijnstrangen VOF and you have the right to data portability. This means that you can submit a request to us to send the personal information we have in your computer file to you or another organization mentioned by you.

You can send a request for access, correction, deletion, data transfer of your personal data or request for withdrawal of your consent or objection to the processing of your personal data to info@derijnstrangen.nl.

To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) black in this copy. This is to protect your privacy. We respond as quickly as possible, but within four weeks, at your request.

De Rijnstrangen VOF also wishes to point out that you have the opportunity to file a complaint with the national supervisory authority, the Dutch Data Protection Authority. This
